## 2025 PARTIAL EXEMPTION LIST

On the pages that follow the reader will find a totals list of the partial exemptions for each taxing entity (16); Leon County, Buffalo ISD, Centerville ISD, Leon ISD, Normangee ISD, Oakwood ISD, City of Buffalo, City of Centerville, City of Normangee, City of Marquez, City of Jewett, City of Oakwood, Southeast ESD #1, Southwest ESD #2, Northwest ESD #3 and Northeast ESD #2.

Partial Exemptions are exemptions applied for by the tax payer that only exempt a portion of the value of a certain account. This type of exemption would normally include general homesteads, Over 65 homesteads, disability exemptions (DV) and widows or surviving spouses of Over 65. It is noted on the first page that includes all of the approved 2024 tax rates that Leon County and the school districts are the only entities that provide a homestead exemption, except as provided in the description that follows. The ESD's all follow the county and are therefore subject to homestead exemptions. A number of the school districts also allow for a local option homestead, which is approved by each individual school district and is in addition to the state mandated homestead exemption. None of the cities allow for a homestead exemption, however, a disable veteran exemption is recognized by all the taxing entities.

The first page of each of the entity totals listed on the following pages clearly outline the number of each type of exemption. The description for each type is coded as follows; H – general homestead, S – Over 65, F – disabled widow, B – disabled, W – widow, DV - disabled veteran and DV100 – 100% disabled veteran.

On the bottom of the second page is a valuation summary for each type of exemption listed under the title of Reimbursable Exemptions.
